NOTICE OF ELECTION OF SCHOOL BOARD MEMBERS
[Sec. 120.06(8)(c)]

Notice is hereby given to the qualified electors of the NORTH CRAWFORD SCHOOL DISTRICT That on Tuesday, April 3, 2018, an election of school board members will be held. The names of the candidates to be voted for, whose nominations have been certified to or filed in this office, are given in the sample ballot below.

Information to Electors

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the school district election, the elector shall make a cross (X) in the square at the right or follow the screen instructions next to the candidate's name for each office for whom he or she intends to vote, or insert or write in the name of the candidate of his or her choice in the space provided.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initiated by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official ballot is marked, it shall be folded so the inside marks do not show but so the printed endorsements and inspectors initials on the outside do show. After casting his or her vote, the elector shall leave the machine or booth, and where paper ballots are distributed to electors, deposit his or her folded ballots in the proper ballot boxes, or deliver the ballots to an inspector for deposit. The unused ballots should be deposited in the blank ballot box, and the elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.
